SUBMISSION OF EVERY TWO YEAR DECLARATION OF INCOME, ASSETS AND LIABILITIES, 2023

Pursuant to the provisions of the Public Officer Ethics Act, 2003 and Administrative Procedures for the Declaration of Income, Assets and Liabilities, 2016 Legal Notice No.53, the Public Service Commission as the responsible Commission for public officers in Ministries, State departments and State Corporations in respect to declaration of income, assets and liabilities wishes to notify that this year's every two year declaration will commence on 1st November, 2023 and close on 31st December, 2023.

It is noted that the Commission trained the Heads of Human Resource Management in all public institutions under its jurisdiction from 22<sup>nd</sup> August to 25<sup>th</sup> August, 2023 on Constitutional Values and Principles and on Declaration of Income, Assets and Liabilities.

You are required to avail the prescribed declaration forms on A3 paper format to all the public officers in your organization on 1st November, 2023. The form is also available in the Commission website <a href="www.publicservice.go.ke">www.publicservice.go.ke</a>. All public officers in your institution have personal responsibility to comply and must therefore submit their complete and accurate every two (2) year declarations of themselves, spouse(s) and dependent children below the age of 18 years on or before 31st December, 2023.

All public organizations under the Commission are expected to submit the declaration returns to the Commission as indicated in the attached schedule (also available in PSC website). The Declaration returns should be submitted with: (i) the forwarding letter ii) the attached prescribed template and (iii) a copy of the October, 2023 payroll. Any public organization under the jurisdiction of the Commission on matters of declarations not assigned a submission date is advised to contact the Public Service Commission.

Officers designated to administer the process in the public organizations are advised to ensure that the returns to the Commission are correct and complete before the submission in order to reduce the likelihood of the declaration forms being rejected and returned to the declarants. The list of compliance, non-compliance should also be reconciled with the in-post and the payroll. All public officers serving in other organizations on secondment are advised to submit their declarations through their substantive employer. All officers in the Service are required to comply, including those officers on leave, overseas engagements (studies, travel and studies) and those on suspension and interdictions.

Further, you are expected to commence and conclude disciplinary proceedings for cases of non-compliance from 2<sup>nd</sup> January, 2024 in accordance with human resource policies and procedures manual and inform the Commission on sanctions taken on or by 31<sup>st</sup> January, 2024.
